Commercial Usage of Unmanned Aircraft Systems (Drone) Permit Agreement

Unmanned aircraft systems (UAS) flying involves a test of a person's physical and mental capabilities and carries with it the potential for death, serious injury, and property loss. Certain risks include burns from fires, electrical shock and electrocution, being struck by a UAS flown by myself or others, failing to follow manufacturers' recommendations, inadequate or defective equipment, inadequate supervision or instruction, and all other risks inherent to UAS flying. In this regard, it is impossible for the Peoria Park District to guarantee absolute safety.

As such, Park District assumes no liability for injury to persons or damage to personal property sustained as a result of Permit Holder's actions. Permit Holder shall indemnify and hold harmless the Park District and its officers, officials, employees, volunteers and agents from and against all claims, damages, losses and expenses, including but not limited to legal fees (attorney's and paralegal's fees and court costs), arising from or in any way connected with (i) Permit Holder's conduct or management of any business or activity performed, or any work or thing whatsoever done, or condition created during the term of this permit; (ii) and act, omission wrongful act of negligence of Permit Holder or any of Permit Holder's members, guests, invitees, or licensees (if applicable), or the partners, directors, officers, agents, employees, invitees, or contractors of Permit Holder or Permit Holder's members, guests, invitees or licensees; (iii) any accident, injury or damage whatsoever occurring during the term of this permit. Such obligation shall not be construed to negate, abridge or otherwise reduce any other right or obligation of indemnity which would otherwise exist as to any party or person described in this Paragraph. Permit Holder shall similarly protect, indemnify and hold and save harmless the Park District, its officers officials, employees, volunteers and agents against and from any and all claims, costs, causes, actions and expenses including but not limited to legal fees incurred by reason of Permit Holder's breach of any of its obligations under, or Permit Holder's default of, any provision of this Permit Agreement. However, Permit Holder shall not indemnify the Park District against actions, costs, expenses, damages and liabilities to the extent attributable to the negligent or wrongful acts of omissions of the Park District.

Permit Holder shall provide commercial general liability (CGL) insurance for this Permit with a minimum limit of not less than one million dollars (\$1,000,000) per occurrence for liability arising from premises, operations, independent contractors, products-completed operations, personal injury, advertising liability, and liability assumed under an insured contract. If such CGL contains an aggregate limit, it shall apply separately to this Permit. The District shall be included as an additional insured under the CGL, using ISO additional insured endorsement CG 20 26 or a substitute providing equivalent coverage, and under the commercial umbrella, if any. The insurance shall contain no special limitation on the scope of protection afforded the Park District. Permit Holder's insurance shall be primary insurance as respects the Park District. Any insurance or self-insurance maintained by the Park District shall be in excess of Permit Holder's insurance and shall not contribute with it. Permit Holder's insurer shall agree to waive all rights of subrogation against the Park District. Before this Permit goes into effect, Permit Holder shall deliver to the Park District a Certificate of Insurance and additional insured endorsement satisfactory to the District.
